**TO ALL MEMBER BANKS
of the Ninth Federal Reserve District:**

In accordance with the provisions of Section 4 of the Federal Reserve Act, as amended, and my communication dated August 17, 2023 in regard to the election of directors of this Bank to fulfill terms succeeding the current terms of Gerald Jacobson, Class A director (eligible for re-election), and Chelsie Glaubitz Gabiou, Class B director (eligible for re-election), whose terms expire December 31, 2023, there are listed on the following pages the names of the candidates nominated for such directorships and their biographical information.

We are providing to each eligible bank in Group 2 access to an electronic preferential ballot for use in voting for one Class B director and to each eligible bank in Group 3 access to an electronic preferential ballot for use in voting for one Class A director. These ballots will be completely confidential, and the results of voting scrambled to ensure that no individual will be capable of matching cast ballots to a voting bank. An officer of your bank who has been authorized by the bank's board of directors to cast the bank's vote must execute the ballot.

The following procedure is required for the Class A and Class B ballots **for those banks that are eligible to vote in this election.**

1. Enter the electronic election website to view current election information.
2. Mark the preferential electronic ballot as instructed on the website between September 20, 2023, and 11:59 pm central time October 4, 2023.

By law, the ballots must be cast so as to be tabulated within 15 days after you have been notified. Therefore, the polls will be open on the dates noted above. After that time, the ballots will be tabulated, and the results of the election will be announced with a posting on the Reserve Bank's public website shortly thereafter. While banks in Group 1 will not vote in this particular election, this circular is posted for them, without voting capabilities, for their information. Likewise, this circular is also posted for the information of those banks in all groups that are subsidiaries of a bank holding company but are not designated banks participating in this election.
