To the Foreign Banking Organization Authorized Official:

The final reporting form and instructions for the *Annual Report of Foreign Banking Organizations* (FR Y-7) effective as of December 31, 2025, have been posted to the Board's [Reporting Forms](#) website.

Summary of Reporting Changes for December 2025

The FR Y-7 report form and instructions were revised to include the standard templates and associated changes that are required as of December 31, 2025, fiscal year-end. Foreign banking organizations (FBOs) with a fiscal year end that is prior to December 31, 2025 (e.g. October 31, 2025), can continue to use the prior format for their FR Y-7 report submission until the following year.

Confidentiality

The FR Y-7 is a public document. Individual respondent data collected on the FR Y-7 reports are available to the public upon request on an individual basis. However, an FBO may request confidentiality treatment for the entire report or for specific items on the report. To better facilitate confidentiality requests and ensure the data are properly handled during the review of the request, the Federal Reserve strongly encourages institutions to review the [Freedom of Information Act \(FOIA\) exemptions](#).

- For institutions that do not submit data electronically, written requests for confidentiality must be provided prior to or concurrently with the paper submission of the report.
- For institutions that submit their reports electronically, written requests for confidentiality must be submitted through Structure Central.

The Reserve Bank cannot fully consider any request for confidential treatment until the reporter provides an affirmative response to questions on the cover page **and** submits a legal justification for the request. The submitted data will be available for public release until the reporter fulfills both requirements. For more information on confidentiality requests, please see the FR Y-7 General Instructions.

The Federal Reserve publishes reporters organizational structure data on the [National Information Center](#). Data is published on a flow basis following receipt of an FR Y-10 submission from the FBO, and updates are run to capture any revisions subsequently submitted.
