To the Chief Executive Officer of the Holding Company:

It is time to file the *Annual Report of Holding Companies* (FR Y-6) for fiscal year-end December 31, 2025. The current version of the FR Y-6 report form and instructions can be found on the Federal Reserve Board's [Reporting Forms](#) website. The FR Y-6 filing deadline is **Tuesday, March 31, 2026**.

Regardless of your intended submission method, portions of your FR Y-6 report need to be completed using Structure Central.

Your holding company (HC) must be enrolled in Structure Central before it can submit its FR Y-6 report.

- If you need to change who is able to log into Structure Central and submit your HC's report, follow the enrollment steps at [Reporting Central and Structure Central Applications Setup](#).
- We highly encourage you to submit the FR Y-6 through [Structure Central](#). If including PDF attachments, please ensure that Adobe's Optimized Character Recognition feature is turned on.
- Retain a signed copy of the completed report for your records. You are required to retain a physical copy of the manually signed report for period of three years following submission.

Reviewing and verifying your organization chart and domestic branch listing

- Both paper and electronic filers must access [Structure Central](#) to review and verify the organization chart (Item 2a) and listing of branches for your subsidiary bank(s) (Item 2b). **Note:** Submit an organization chart only if there are changes to entities that are exempt from FR Y-10 reporting.
- Legal Entity Identifiers (LEIs) for entities within your organization may have been newly obtained, recently lapsed, or reinstated after lapsing. Check www.gleif.org to confirm the status of your organization's LEIs and mark the appropriate response in Structure Central.
- If there are any discrepancies to either Items 2a or 2b with your internal records, including LEI changes, please submit an FR Y-10 report.

Reporting changes from prior year's Items 3 and 4

Only include responses to these items if there are changes from prior year's report:

- Use the templates provided within Structure Central.
- Do not modify the column headings or overall design.
- Add your holding company's legal name in cell B1 on all tabs of the templates.
- Provide responses to all columns for each submitted reported individual, securities holder, or insider. Add "None" or "N/A" if a specific item is not applicable.

Confidentiality

The FR Y-6 is a public document. Individual respondent data collected on the FR Y-6 reports are available to the public upon request on an individual basis. However, an HC may request confidential treatment for the entire report or for specific items on the report. To better facilitate confidentiality requests and ensure the data are properly handled during the review of the request, the Federal Reserve strongly encourages institutions to review the [Freedom of Information Act \(FOIA\) exemptions](#).

- For institutions that do not submit data electronically, written requests for confidentiality must be provided prior to or concurrently with the paper submission of the report.
- For institutions that submit their reports electronically, written requests for confidentiality must be submitted through Structure Central.

The Reserve Bank cannot fully consider any request for confidential treatment until the reporter provides an affirmative response to questions on the cover page **and** submits a legal justification for the request. The submitted data will be available for public release until the reporter fulfills both requirements. For more information on confidentiality requests, please see the FR Y-6 General Instructions.

The Federal Reserve publishes reporters organizational structure data on the [National Information Center](#). Updates are run nightly to capture any revisions submitted by the reporting institutions.
