




Income Distribution of the United States, All People, 1989 and 2020


Change in the Income Distributions of the United States, All People, 1989 and 2020

- Inform economic practitioners and policymakers with credible, objective research that can advance economic prosperity for Indian Country.






CICD's Data Initiative facilitates expanded data work

2022 data initiative expansion: Federal Reserve System effort to strengthen data and research to inform economic policy and economic development in U.S. Indigenous communities

Aim: Make data available and easier to find and use for economic empowerment in Indian Country—and do that in a good way.

Building on Native Community Data Profiles



- Native Community Data Profiles offers an easy-to-use, placebased snapshot of economic and demographic conditions
- Visualizes the most recently available data from more than a dozen public sources
- Engagement with community members and data users highlighted ongoing data needs...
 - What does this data look like over time?
 - What if I want to look at data for multiple areas at once?
 - How does my geography compare to other areas?
- That feedback directly shaped the development of a new interactive tool...

A new interactive tool designed to support Native communities in exploring how conditions have shifted over the past three decades—highlighting changes in economic opportunity, education, housing, and more.






Considerations for data use

- Place based ≠ Native-entity based
- Census estimates **≠** directly measured quantities
- Methodological changes such as differential privacy and changes in question formatting and instructions impact the stability of data over time
 - Smaller American Indian, Alaska Native, and Native Hawaiian Areas are most affected
- These extreme shifts often reflect methodological changes and differences between surveys, not actual demographic change

Data note: This datapoint represents a small number of observations (N = 142); use care when interpreting.

Data note: Respondents could self-identify beginning in 2000 as more than one race. This may affect the comparability of this datapoint to before that time.


Data note: The U.S. Census Bureau applied new privacy protection measures in this data year. This may affect the comparability of this datapoint to previous years.








Native American Funding and Finance Atlas



Native American Financial Institutions Map




Native American Labor Market Dashboard
